RESEARCH INTERESTS & SHORT BIO

I am a tenured Professor of Law at Rutgers Law School where I teach Contracts, Corporate Social Responsibility, Remedies, and a Practicum on International Business & Human Rights Law. My research explores innovative legal mechanisms for improving the social and environmental performance of multinational corporations.

I founded Rutgers Law School's Business & Human Rights Law Program in 2022. The Program's flagship initiative is the [Responsible Contracting Project](#) (RCP), which I direct. RCP is a grant-funded non-profit initiative whose mission is to drive better outcomes for people and the planet through better, more responsible contracts. In recognition of RCP's pioneering contributions to corporate social responsibility, I was named a Sustainability Thought Leader by Vogue Business magazine in 2025.

In addition to running RCP, I serve as a leading member of the ABA Business Law Section's Working Group to Draft Human Rights Protections in International Supply Contracts, as well as the European Working Group on Responsible and Sustainable Supply Chains.

Before joining Rutgers in 2013, I was Legal Counsel at the International Fund for Agricultural Development (IFAD), a specialized agency of the United Nations based in Rome, Italy. Prior to that, I was a Fellow at NYU Law School's Institute for International Law and Justice and an associate attorney at the global law firm, Allen & Overy, now A&O Shearman.
