SELECTED CASES

Innocence Project (lead counsel on exonerations of eight people who spent a total of over 175 years in prison):

Commonwealth v. Garr Keith Hardin & Jeffrey Clark, 528 S.W.3d 342 (Ky. 2017). Obtained reversal of 1995 murder convictions based on newly discovered evidence, affirmed by Kentucky Supreme Court (argued June 2017), and obtained dismissal of new indictments with prejudice for vindictive prosecution. Detective from Louisville Metro Police Department was subsequently criminally indicted.

State v. Darryl Howard (N.C. 2016). Obtained reversal of 1995 double murder and arson convictions resulting from fabrication of evidence by Durham police and misconduct by Assistant District Attorney Mike Nifong.

Kramer Levin:

In re Guantánamo Bay Detainee Litigation, 581 F. Supp. 2d 33 (D.D.C. 2008) (ordering the federal government to release into the U.S. seventeen Uighur men held in Guantánamo), *rev'd and remanded sub nom. Kiyemba v. Obama*, 555 F.3d 1022 (D.C. Cir. 2009), *vacated*, 559 U.S. 131 (2010), and *judgment reinstated as amended*, 605 F.3d 1046 (D.C. Cir. 2010). Represented four Uighur men held in indefinite detention in Guantánamo; litigated habeas cases in district, appellate, and U.S. Supreme Court; and co-led resettlement efforts before foreign ministries, overseas courts, asylum sponsor programs, and Office of the United Nations High Commissioner for Refugees.
