3. Brief description of your organization:

The American Friends Service Committee Immigrant Rights Program integrates legal services, advocacy, and organizing, providing legal representation in a wide variety of challenging immigration cases. Legal representation is provided to indigent New Jersey residents in our Newark and Red Bank offices, including immigrants in removal proceedings, individuals in detention, children, survivors of domestic violence and other crimes, asylum seekers, and individuals with mental health challenges.

4. Brief description of summer internship responsibilities and qualifications:

The Maida Fellow will work with AFSC attorneys to conduct intake interviews to determine eligibility for immigration benefits such as asylum, cancellation of removal, VAWA, U visa, Special Immigrant Juvenile Status, TPS, and other forms of immigration relief. The Fellow will assist in research and case preparation for clients represented by AFSC. The internship will offer the opportunity to work directly with clients, and to observe and participate in immigration court proceedings (detained and non-detained), as well as USCIS interviews. Fluency in a second language, particularly Spanish, is preferred.
