South Jersey Legal Services, Inc. is a non-profit organization created to provide quality legal representation and advocacy to low-income individuals. We seek to empower low-income individuals to access to the judicial system so they will achieve the greatest possible measure of substantive procedural, social and economic justice.

SJLS serves Atlantic, Burlington, Camden, Cape May, Cumberland, Gloucester, Monmouth, Ocean and Salem Counties. With more than 50 years' experience, SJLS is part of the Legal Services of New Jersey network and a recipient of funds from the federal Legal Services Corporation. In addition, SJLS receives funds from other federal, state, and local government sources, several county offices on aging, the United Way of Philadelphia and South New Jersey and other public and private grantors.

4. Brief description of summer internship responsibilities and qualifications: SJLS seeks interns who have demonstrated their commitment to helping the disadvantaged through prior work, extracurricular activities during school and volunteer efforts. Rising third-year law students are given some priority due to the special New Jersey Court rule under which students employed by Legal Services offices and other legal aid programs may be certified to appear in a number of State courts. Outstanding rising second-year students will also be considered. Our interns gain experience in a wide variety of public interest legal issues.

While specific responsibilities vary considerably according to individual placement, the range of activities typically
