Volunteer Lawyers for Justice (VLJ) is a comprehensive, statewide legal assistance program based in Newark, New Jersey. VLJ's mission is to ensure access to justice for people experiencing poverty by empowering them with the tools, advice, and pro bono representation needed to obtain fair and equal treatment within the legal system. To carry out its mission, VLJ operates a number of distinct legal programs, which include a Debt Relief (Bankruptcy and Consumer Debt) Program, Children's Representation Program, Divorce Program, South Ward Promise Neighborhood Program, ReLeSe (Reentry Legal Program), Tenancy Program, Trafficking Victims Legal Assistance Program, and Veterans Legal Program. VLJ's summer internship program provides students with an opportunity to gain valuable experience interviewing clients, performing legal research and writing, and interacting with in house staff attorneys and private attorneys who serve as pro bono attorneys for VLJ. Students will be assigned to several of VLJ's programs and will gain substantive legal knowledge in a number of legal areas. Candidates will have a shared motivation to working toward VLJ's mission and a readiness to engage directly with clients, VLJ staff and attorneys, and contribute substantively to providing legal services across programs to make our mission a reality. VLJ seeks highly motivated law students with a demonstrated commitment to public interest and excellent communication and interpersonal skills. Fluency in Spanish is a plus, although not required.
