

**EXAM SCHEDULE - FALL 2020 SEMESTER**

Unless otherwise noted, the exam window for day courses and any exam scheduled on a Saturday below is 8 AM to 4 PM. Evening course exams will have a window of 4 PM to midnight.

So, if you have a 3 hour exam for a day course and the window closes at 4pm but do not start until 1:30 pm, you will not have three hours available to you to finish the exam. (As of 12/15/2020)

For exams starting at a specified time (10 am, for example), all students must start the exam at the specially designated time.

The exams will be available on the law school website under "Take an Online Exam" (unless otherwise noted).

The number of hours are tracked via the web exam system and please remember to save your work regularly.
