1. Marshall-Brennan Constitutional Literacy Project Fellowship:

Yearlong seminar and associated field placement to teach Camden-area high school students about the Constitution.

Fall	Spring
Seminar about Bill of Rights (special emphasis on jurisprudence about young people and school), educational inequity, poverty. Seminar includes extensive training in teaching skills and “on your feet” workshopping.	+/- 2-4 days per week (40-75 minutes per day) as a high school civics teacher. Many students describe this as among their most meaningful law school experiences and most gratifying life experiences.
Possible 1 hour per week coaching high school moot court.	Continued seminar, scheduled flexibly
Writing intensive optional	Participation in national high school moot court competition
2 graded credits + 1 “lab” ungraded, non-course credits for out-of-class trainings or longer workshop sessions attached to class meetings	3 ungraded, non-course credits
