VLJ is a comprehensive, statewide legal assistance program based in Newark, New Jersey. VLJ's mission is to improve the lives of economically disadvantaged and at-risk adults, children, and families in New Jersey by empowering them with the tools, advice, and representation to obtain fair and equal treatment within the legal system. VLJ provides legal education, advice, and direct legal service to the over 400,000, or one out of three, New Jersey residents living at or below poverty who face a civil legal problem each year. With six attorneys on staff, VLJ works to leverage the most legal resources for low-income clients in need. Not only do VLJ's staff attorneys manage their own case loads, but they also recruit, train, and mentor hundreds of volunteer attorneys to provide legal services to thousands of clients per year. VLJ operates distinct legal projects in the areas of bankruptcy, consumer law, divorce, child support, landlord-tenant, education, prisoner reentry, trafficking victims legal assistance, and veterans' issues.

An internship with VLJ will provide law students with a unique opportunity to interview clients, draft pleadings and perform legal research. VLJ interns will be exposed to all of the legal issues handled by VLJ and interns attend our legal clinics, several of which are held at the Essex County Courthouse. VLJ coordinates clinics in consumer law, bankruptcy, divorce, child support, driver's license restoration, criminal record expungement and veterans' issues. In addition to working with VLJ staff and clients, interns also have the opportunity to work with VLJ's extensive pro bono attorney panel. Student interns work under the supervision of VLJ staff attorneys.

Applicants must have strong communication, advocacy, organization and writing skills. Previous experience working with low-income populations and/or people in crisis is preferred. Proficiency in Spanish is also a plus.
